To any of the Constables of the Town of Gill in the County of Franklin,

Greetings:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the inhabitants of said town, qualified to vote in elections and in town affairs, to meet at the Gill Town Hall in said Town on Monday the 11th day of December next, at 6:30 p.m. o'clock in the afternoon then and there to act on the following articles:

Article 1: To see if the Town will vote to comprehensively revise its existing Zoning Bylaws by adopting a new Zoning Bylaw in the form available at Town Meeting labeled Town Meeting Version and dated November 21, 2006 and to adopt a new Official Zoning Map dated November 21, 2006 or take any other action related thereto. The complete text of the proposed Zoning Bylaws and Official Zoning Map is available at the Town Clerk's office during their regular business hours, or take any other action relative thereto.

Article 2: To see if the Town of Gill will vote in accordance with M.G.L. c 40 §4A to authorize the Gill Selectboard and the Board of Health to enter into an intermunicipal agreement with one or more other governmental units to provide public health, public works, and general government administration services which the Board of Health, Highway Department, and other administrative bodies in town are authorized to perform, in accordance with an Intermunicipal Mutual Aid Agreement to be entered between the Town and various governmental units, or take any other action relative thereto.

Article 3: To see if the Town will vote to transfer from available funds a sum of money to add to monies previously appropriated to provide for a recollection of data, purchase of assessing software, conversion of data, training and services related to the mandated triennial certification for the Assessors office, or take any other action relative thereto.

Article 4: To see if the Town will vote to transfer from available funds a sum of money to provide for FY2007 interim valuation adjustment services, or take any other action relative thereto.

Article 5: To see if the Town will vote to transfer from available funds a sum of money to revise the Town of Gill's Center Cemetery's surveys, or take any action relative thereto.

Article 6: To see if the Town will vote to accept donations from the Gill Fireman's Association for one 1987 Chevrolet V-30 Pickup truck VIN# 1GBHV34K8HS138875 currently equipped with a water tank and portable pump for brush and forestry firefighting with an estimated value of \$2,880, one sixteen-foot aluminum-hulled Model 1600 Connector Boat HID: TJZ127KGA606, one 2006 40 horse-power Mercury Marine outboard motor Serial #1C004266, and one boat trailer VIN 4RPBB16124C019942 with a combined estimated value of \$18,000, to be kept and maintained by the Gill Fire Department and made available for use by Town personnel for training, rescue and firefighting purposes, or take any action relative thereto.

And, you are directed to serve this Warrant, by posting up attested copies thereof at the Town Hall, Main Road; Post Office, Mt. Hermon; The Gill Store, Main Road; and Riverside Municipal Building, Route 2, in said Town fourteen days at least before the time of holding said meeting.

Hereof fail not, and make due return of this Warrant, with your doings thereon, to the Town Clerk, at the time and place of meeting, as foresaid.
