Store for allowing a recent meeting to move its venue to the deli tables in the backroom, when no one in attendance had a key to Town Hall! Peggy Sloan and Tracy Zafian, Planners from the Regional Council on Governments didn't miss a beat and continued to guide interested citizens in designing zoning that reflects what it is folks love about Gill and want to preserve for future generations. This doesn't just happen, you must plan for it! It's called Smart Growth and is made possible by a grant from the State Executive Office of Environmental Affairs. Times and dates of Smart Growth Zoning Initiatives are posted at the Town Hall, on the website and as news notes in the local papers (within our control). A public informational meeting will be coming up soon ~ watch for announcements and participate in the process!

Town Meeting Update

Since the close of Town Meeting, the Gill-Montague School Committee has voted to further reduce their assessment to the Towns, dropping Gill's assessment by approximately \$23,000 from what town meeting approved on June 26th. However, the Committee has requested additional funds be allocated to update curriculum and instruction for all students in preK-12, supporting two new programs in Mathematics for grades K-6 and 7-8, texts and materials in Reading for K-6, and technology support and maintenance for the data center/master servers and HVAC management

system at the middle/high school. The total request is for \$165,000, with Gill's percentage at \$23,100 (14%). Since it is a request and not an assessment, we cannot simply use the excess voted at Annual Town Meeting. The reduction of the number voted at Annual Town Meeting to reflect the new assessment will occur as part of the tax rate setting process by the Assessors (a recap of appropriations/assessments approved offset by anticipated revenues), and does not require further action by Town Meeting. We cannot pay more than we are assessed. However, the request for additional funds would have to be voted by Town Meeting at a special town meeting, tentatively planned for August 21, 2006.

Thank you to the 130+ voters that showed up for Annual Town Meeting continuation June 26th! A brief synopsis follows.

The 2005 Annual Town Report was accepted with the following changes:

- 1) Page 26 – to include the addition of grants acquired by the Fire Department;
- 2) Page 72 – calculation of subtotals omitted on the Trust Funds Accounts for North Cemetery;
- 3) Page 20 –Assessors report the word Exemptions should replace the word Abatements under Real Estate; and
- 4) Page 12 – Personnel Committee date of resignation for Sandy

Brown should reflect June, not January.

The usual election of Fence Viewers; Measurers of Wood, Bark and Surveyors of Lumber and field drivers - all for one year occurred along with annual acceptance of Federal and State funds for road-work. Town meeting voted to Passover the article for a full-time firefighter and two additional articles that were included as contingency in the event another was not.

Affixing the salaries of town officers brought forth lots of discussion, with an amendment from the finance committee to reduce the salaries of town officials by reducing the proposed annual cost of living increase 1% from 3 1/2% to 2 1/2% for town officials, which passed.

Town Meeting supported an article for recollection of data for property town wide, which will include an upgrade of collection software, training and related services from funds previously appropriated by Town Meeting: \$25,000 from monies approved last year for replacement of the Gill Elementary boiler (which only needed repair, not replacement), funds accruing from prior year's appropriation for revaluation in the amount of (\$11,009.67) and \$24,617.05 from funds appropriated for prior years to provide for abatements and non-payment that was no longer needed for a total of Sixty Thousand Six Hundred Twenty Six Dollars and Seventy-Two Cents (\$60,626.72).



Town meeting also supported purchase in two installments of \$2,200 a used voting machine and maintenance contract for the Town Clerk to replace an antiquated machine that was no-longer serviceable.

The omnibus budget supporting the operation of town services in Gill passed as presented except for two changes, suffering the same reduction in COLA (1%) for Town employees as did town officials salaries and returning the Recreation Commission to \$3,600 for a total appropriation of \$2,335,785.69 after available funds were applied. **See pages 10 and 11 for the approved Omnibus.**

Town Meeting supported three new bylaws regarding the regulation of dogs and noise, in addition to establishing an Agricultural Commission of five members to represent the Gill commercial farming and agricultural community that go into effect upon approval by the State Attorney General's office.

Town meeting approved acceptance of M.G.L. Chapter 32B, §18 requiring that all town employees that retire while in the Town's employ, and their spouses and dependents, at retirement age be required to enroll in a Medicare health benefits supplement plan. Acceptance merely removes the option of the retiree and eligible dependents staying on the Town's full-health care plan, which will provide a savings to both the town and the employees.

From 1 to 3 PM there will be the popular hayride with a horse drawn wagon and music by the Fall Town String Band from our neighboring town of Bernardston. The sawdust coin hunt, a favorite with children, will be held at 2:00 PM. This festive mid-summer occasion offers Gill residents the opportunity to meet each other in a casual setting.

Bernice Keach Memorial Scholarships

The high school graduates who this year were awarded \$500 Bernice Keach Memorial Scholarships by the Friends of Gill were Paul Marguet and Nathan Underwood. Mrs. Keach was a founding member of the Friends and a driving force in the early years of the organization.

Gill Job Fair

The Town of Gill will host a "Job Fair" on Monday, August 7, at the Town Hall. Members of the Fire Department will be available, beginning at 7:00 PM, to answer questions and share information about our important service. The Fire Department is always seeking new members, especially able-bodied men and women who are available to answer alarms between the hours of 7:00 AM and 4:00 PM. The Fire Department answers approximately two hundred alarms each year and provides training in basic emergency medical care and firefighting techniques. Most training sessions occur on Thursday evenings from 7:00 to 9:30, though there are a few weekend classes as well as optional training sessions designed to improve skills. If you are interested in joining us, you may call 863-8955 to make arrangements to attend one of our weekly drills. There is no better way to decide if you want to become a member of the Fire Department than to see it for yourself.

Fireworks Reminder

According to Massachusetts Fire Incident Reporting System data, there were 577 major fires involving illegal fireworks between 1996 and 2005. These fires caused 17 civilian injuries, 9 fire service injuries, and 2 civilian fatalities. The use of fireworks by anyone in Massachusetts, except licensed professionals, is illegal.

Cardiac Concerns

Most people expect a heart attack to occur like those portrayed in television shows and movies where the victim experiences sudden chest pain and falls to the floor. The truth is that heart attacks occur differently in different people and the symptoms vary greatly. The onset of a heart attack may last only seconds, several hours, or even days. Chest discomfort, like pressure, squeezing, fullness, or pain in the center of the chest, may be the sign of a heart attack. Many victims feel discomfort in one or both arms, back, neck, jaw, or stomach. Shortness of breath may come before or with chest discomfort.

Victims may also feel nauseous, light-headed, or break out into a cold sweat. A few victims never even know they have had a heart attack. Heart attacks are serious. Anyone who suspects a heart attack should call 911 immediately. The Fire Department and responding ambulances carry life-saving equipment that can improve a victim's chances of survival.

Outdoor Cooking Fires and Fireplaces

Each summer, the Fire Department receives inquiries regarding the regulation of outdoor cooking fires and fireplaces. A number of these inquiries result in the Fire Department responding to the scene of small residential cooking fires and returning to the station without taking any further action. State Fire Marshall Stephen Coan of the Massachusetts Department of Fire Services advises citizens that open-air fires are generally regulated pursuant to M.G.L. c.48 s.13, which states in pertinent part that, "No person shall set, maintain or increase a fire in the open air...except by permission... granted by the Forest Warden or Chief of the Fire Department, or Fire Commissioner." There is, however, a statutory exception for outdoor cooking. This exception is limited to persons eighteen years of age or older who may, without a permit, set, maintain, or increase a reasonable fire for the purpose of cooking as long as the fire is enclosed within rocks, metal, or other non-flammable material and safely away from residences and vegetation. The Fire Marshall also advises that if a local fire chief believes the conditions of an outdoor fire are likely to cause a risk of greater fire, the chief may issue orders to immediately remedy the dangerous condition, including extinguishing the fire. The Gill

Fire Department appreciates the statutory right of citizens to conduct reasonable and safe outdoor cooking fires and asks that residents take into consideration the potential effects of smoke or other fire-related nuisances upon their neighbors.

Gas BBQ Grills

Each summer the Fire Department responds to incidents of LP gas expansion in overfilled cylinders. Most gas cylinders leak from a safety valve that is activated as the gas expands due to hot daytime temperatures. LP gas is heavier than air and sinks into low areas making a leaking gas cylinder a significant hazard around even the most unlikely ignition sources. Smoking materials, air conditioners, pilot lights, air compressors, and vehicle engines have all been known to cause LP gas explosions. If you are planning to use an LP gas grill this summer, keep the grill at least ten feet away from your house and other structures when in use. Keep the grill away from building openings, like doors, windows, dryer vents, and air intake vents. Make sure all connections are tight and secure before you light the grill. Of course, supervise children when a gas grill is in use. When grilling is done, store the cylinder in a well-ventilated place and keep it away from the living spaces and possible ignition sources. Enjoy your summer barbecues and grill safely.

Fluorescent lights save energy, but contain MERCURY
Mercury lamps **DON'T** belong in the trash
RECYCLE your mercury lamps

Regulations

- State (310 CMR 30) and Federal regulations ban the disposal of lighting that contains mercury in the trash.
- These lamps include straight fluorescents (including green tipped lamps), U-tubes, High Intensity Discharge, Sodium Vapor, tanning lamps, and other lamps commonly used by businesses and institutions .

Storage and Handling

- Change spent lamps carefully.
- Place lamps in their original box or specialized fiber containers provided by your recycler.
- Store spent lamps in a safe place where they will not get wet or knocked over.
- Lamps can be stored for up to one year.
- Boxes containing spent lamps should be marked with the following: "Universal Waste-Lamps" and the date accumulation began.

Breakage

- While accidental breakage is unavoidable, it is illegal and dangerous to intentionally break lamps.
- If a lamp is broken, carefully sweep up the debris and double bag it in plastic bags.
- The broken lamp should be stored separately in its own container for your recycler.
- Avoid vacuuming broken lamps. Vacuuming has been proven to spread spilled mercury.
- If a large number of lamps break, there is a high potential for exposure to airborne mercury. Immediately close off the area with the broken lamps and call a local hazardous materials response agency, usually the local fire department.
