## Town Hall News

### Results from Special Town Meeting

The special town meeting held on February 25 contained some routine articles and some not so routine. There was a vote to fully fund the Gill-Montague Regional School District FY08 budget, which finalized the town's FY08 budget as well allowing us to set a tax rate and send out the tax bills. Town meeting also took up the weighty matter of changing the section of the school district agreement regarding the closing of schools. It also voted to designate the Mariamante parcel on Main Road a "priority development site" under Chapter 43D of M.G.L. and approved the town filing a grant application for technical assistance in developing and marketing the property throughout the state and nation.

There were two articles during the meeting that were passed over until more information could be obtained. One was to create a Capital Improvements Planning Committee (CIPC). Questions arose as to whether the functions of a CIPC could be carried out by an already existing town board or committee—perhaps the Finance Committee or Building Committee. The second article was to allow the tax collector to bill residents quarterly for real estate taxes, rather than the current semi-annual system. It is likely that both articles will be discussed again during the annual town meeting.

Speaking of Annual Town Meeting, per town bylaw it will be held the first Monday in May—Monday, May 5, 2008—at 7:00 p.m. in the upstairs room at Town Hall.

### New Fee Schedules

The Selectboard has recently reviewed the fee schedules throughout town departments and committees and brought them more in line with those of surrounding communities. These fees include items such as: a Title V inspection report review, food service licenses, seasonal camps or pool permits, smoke detector certificates, oil burner permits, curb cut permits, and special permit applications. ## Gill Montague Education Fund Gala

Tickets go on sale March 15 for the annual Gill-Montague Education Fund Gala, which this year will feature Don Campbell and the Don Campbell Band. The event will take place Saturday, April 26, at 7:30 p.m. in the state-of-the-art theater at Turners Falls High School.

"We're going to take the audi-

ence on a comfortable rollercoaster ride of contemporary and traditional country with a sprinkling of bluegrass, Americana, western, and even barn dance. We'll blend original music I've written, which I hope new fans will enjoy discovering as well as some favorites/standards that people can toe-tap or sing along to as we explore a wide and wonderful range of country music," said Campbell, who was named Maine's best singer-songwriter for four years in a row (2004-2007) in the Maine *Sunday Telegram's* Annual Readers Poll. "We'll be showcasing songwriting and musicianship and of course storytelling, as this is a huge piece of country, perhaps its core essence. We'll talk about many of the songs and have a great time with the audience."

Campbell is the recipient of Distinguished Achievement Award from the University of Maine at Augusta, the national grand prize winner of the 18th Annual Country Showdown, the national grand prize winner of the Jim Beam Country Band Talent Search, and the Just Plain Folks Awards Male Artist of the Year/Holiday Song of the Year. He wrote the national theme song for the Visiting Nurse Associations of America.

Campbell and his band mates have opened for Willie Nelson, Merle Haggard, Randy Travis, Tanya Tucker, Charlie Daniels, American Idol winner, Carrie Underwood, Toby Keith, Keith Urban, Ricky Skaggs, Shawn Colvin, Gretchen



Wilson, Big & Rich, JoDee Messina, Travis Tritt, and others.

Funds raised through the gala will be used to fund educational enrichment opportunities in the schools of the Gill-Montague schools district.

“With economic pressures coming from a variety of sources, it becomes that much more important to encourage and foster arts in the schools through innovative means,” Campbell said. “When the GMEF folks were in touch with us about their concert concept, it was exciting to us as so much of the community is involved.”

He has been able to spend time at the high school through the planning and promotion piece of the concert and come to feel even more vested in coming to the area with his band for the April 26 event. “Two of our band members are music teachers, providing guitar, piano and violin/fiddle lessons when they aren't performing,” he said. “Music and learning go hand in hand with whom we are as a performance and recording group, so working with the GMEF felt like a very nice fit.”

### Brush Permit Season

Brush burning season runs from January 15 to April 30, 2008. Town residents who wish to burn brush, sticks, or fallen tree limbs may contact Shelburne Control at 625-8200 to obtain a permit. Fires must be at least 75 feet from buildings, contained, and attended. Residents may not burn trees, logs, stumps, leaves, trash, or demolition materials. Fires must begin before noon and be completely extinguished before 4:00 PM. Call the Fire Department at 863-8955 if you need further information on brush permits.

### Seeking New Members

The Gill Fire Department could always use a few more members, especially during the work day. The Department provides the necessary equipment and training for new firefighters, who must be at least sixteen years of age. Preliminary training includes personal protective equipment, fire behavior, basic firefighting skills, first aid, and CPR and defibrillation. More advanced training opportunities in pump operation, hazardous materials response, rope and water rescue, emergency medical technology, and other areas are available





throughout the year. Remember, a community's volunteer fire department is as good as the people who make it work. If you live in Gill and you are physically up to the challenge of serving as a firefighter, we may be looking for you. The Town of Gill is an equal-opportunity employer and its emergency services personnel are subject to criminal background (CORI) checks. The Gill Fire Department meets each Thursday evening at the fire station from 7:00 to 10:00. For more information, call the fire station at 863-8955.

## News from Franklin County Solid Waste Management District

### How to Dispose of Household Batteries

There are many different types of household batteries and some contain mercury and other heavy metals. Batteries can release mercury, cadmium or other heavy metals into the air and water, ultimately entering the food chain and posing health threats to people and the environment. Please read below for disposal instructions for specific battery types. There are no charges for recycling these batteries.

**Rechargeable batteries** are found in those electronics and appliances that can be recharged, such as cellular and cordless phones, cordless

power tools, laptop computers, camcorders, remote-control toys, two-way radios, electric toothbrushes and razors, and emergency medical equipment. Rechargeable batteries contain heavy metals and should *never* be thrown away; they should always be recycled. All towns in the Franklin County Solid Waste District have been supplied with a special "Call 2 Recycle" box for rechargeable battery collection. Gill's collection box is at the Gill town hall. The specific battery chemistries accepted in these boxes are: Nickel-cadmium (Ni-cad), Nickel Metal Hydride (Ni-MH), Lithium Ion batteries (Li-ion) and Small Sealed Lead (Pb), plus cell phones and their batteries.

**Button batteries** are the small, round and silver batteries found in watches, clocks, calculators, hearing aids, and in some toys and household items. Button batteries contain mercury and must be disposed of properly. All towns in the Franklin County Solid Waste District have been supplied with a collection canister for the recycling of button batteries. Gill's collection canister is at the Gill town hall.

**Alkaline (flashlight) batteries** are the most common household batteries. They are not rechargeable and available in many sizes and shapes such as AAA, AA, C and D. Alkaline batteries manufactured since 1994 do not contain added mercury and can safely be disposed of in a landfill. It is safe to put alkaline batteries in Gill's trash, since Gill's trash is sent to a

landfill. (This procedure differs in each town; for other towns, please contact the District office.)

### Save the Date! (and save those confidential papers!)

On Saturday April 19 from 9 AM – 1 PM there will be a free paper shredding event in the Greenfield Staples parking lot. This has been scheduled to celebrate Earth Day and also to provide a way to safely recycle confidential papers after this year's tax filing deadline. Participants can deliver up to one full recycling bin of paper for destruction and watch their paper being shredded on site. After shredding, all paper will be brought to the Springfield MRF for recycling ([www.springfieldmrf.org](http://www.springfieldmrf.org).) This event is a part of the statewide Mass Recycles Paper campaign and strives to educate the public that shredded paper is recyclable. The best way to recycle shredded paper at home or at the office is to put in a paper bag and, to help avoid a mess or litter, staple the top shut. Plastic bags are not acceptable in municipal recycling programs; please do not put shredded paper in plastic bags.
