## Town Hall

### Change to Billing Cycle for Riverside Water & Sewer Customers

The Commissioners of the Riverside Water District, in conjunction with the Gill Selectboard (as sewer Commissioners), have announced a change in the dates of the quarterly bills, in order to better coincide with the District's and Town's fiscal years.

Meter readings will now be taken at the end of December, March, June, and September. Bills will be issued in January, April, July, and October.

In order to switch to the new schedule, the next bill will be issued in January 2017, and will have a four-month billing period instead of the usual three. After that, water and sewer bills will return to the three-month billing period. Thank you in advance for your patience and understanding during this changeover.

### Snow Reminders

The Water Commissioners ask that residents shovel snow away from the fire hydrants after each snowstorm. Also, please keep your outside meter clear of ice and snow for the readings. In accordance with the Town's Winter Parking Ban, there is **NO ON-STREET PARKING** allowed between the hours of 1 AM and 6 AM, November 1 through April 15. Your cooperation is greatly appreciated.

## Gill Police News

### Traffic Markings to be Fixed

Gill's police department has been notified of some welcome news regarding the Main Road and French King Highway intersection. The call came last week from Mary Jane Bacon, District Staff representative for Senator Stanley Rosenberg. After many phone calls from both Gill residents and staff members of the Gill Police Department, the MA Department of Transportation has agreed to change the traffic markings coming northbound off the Gill- Montague Bridge. Currently the signage and markings indicate the "Straight" lane is for Left Turn Only, and pulling into the right lane approaching the intersection is for turning right and/or going straight. This change has created many close-call accidents, since most of the motoring public is used to going straight in the Left Turn Lane as it is currently marked. We look forward to the correction coming very soon. Until then please use care driving through the intersection.

### Cameras on French King Bridge

On the 19th of October the first step of the camera installation will be taking place on the French King Bridge to better identify safety issues on the bridge. After many years of working with the State House, MA DOT, MA State Police, the Erving and Gill Selectboards, Fire Departments and Police Departments, the State has found the funding to place a camera on both sides of the bridge that will allow both community police departments to monitor activity on the bridge. It is not yet known when the camera will be activated,

but this is a big step forward for the safety of many, especially when it comes to the potential water-rescue of an individual.

The Gill Police Department wishes to thank the office of Senate President Rosenberg and his district staff member Mary Jane Bacon for being instrumental in assisting our community in these two matters.

## Public Health

### In-Town Flu Clinic on November 2

FRCOG's Cooperative Public Health Service is partnering with Gill Elementary, GCC School of Nursing and community volunteers to hold a public flu clinic on **Wednesday, November 2** from 3:30-5:30 PM at **Gill Elementary School**. Insurance cards (Medicare, MassHealth and commercial insurances) are accepted. For those without insurance the cost is \$10 for children or \$20 for adults. This year only injectable flu vaccine will be offered. The Advisory Committee for Immunization Practices has made an interim recommendation that nasal spray form of the vaccine, FluMist (LAIV), should not be used for the 2016-17 influenza season. There are no concerns about the safety of LAIV. This decision was made in light of evidence of LAIV's poor effectiveness against influenza A (H1N1) in the U.S. during recent seasons. The ACIP will continue to monitor data about LAIV and continues to recommend injectable forms of flu vaccine for everyone 6 month of age and older.

## Gill Historical Commission

Phase 2 of the Great Falls Battlefield Project has officially begun with Ivan Ussach continuing to serve on the Project Advisory Board. A Scope of Work and RFP (request for proposal) for the consultant/principal investigator are both being drafted for submission to the National Park Service for approval, with the consultant team expected to be selected in January. The Project Board meets on the first Wednesday of the month from 11 – 1 at the Montague Town Hall; the meetings are open to anyone who is interested.

Preliminary archaeological fieldwork for the Gill Mobil convenience store project has been completed with no significant finds confirmed; the owner's consultant

(UMass Archaeological Services) has recommended that Native American monitors be present onsite during construction, an approach endorsed by various government, native, and local stakeholders. The GHC will continue to monitor the progress on this project.

The GHC is currently reviewing a proposal by Northfield Mount Hermon to replace their Speer boathouse, a project that the Massachusetts Historical Commission has noted includes some archaeologically sensitive areas and for which they are requesting a reconnaissance survey be completed. An on-site walk is scheduled for October 19.

The Historical Commission's recent publication, *Riverside – Life Along the Connecticut River*, sold out 200 copies within ten days of the first printing. Copies from the second printing are being sold, and it is gratifying that many who bought the book in September are ordering copies for holiday gift-giving. See the information box below if you wish to order a book. Proceeds from sale of the book support preservation and projects, and the GHC hopes that the book will encourage pride in Gill history.

The Massachusetts Historical Commission (MHC) is still reviewing our nomination forms for part of Riverside to be approved for honorary listing on the National Register of Historic Places. Meanwhile, the forms for listing Gill Center have been revised to meet requests from MHC and re-submitted with another set of photographs. A reminder: MHC's review process takes several years and will eventually include meeting with residents. The GHC supports the honorary listing but does not propose local historic districts that carry restrictions on properties. From the application to the Massachusetts Historical Commission (page 14): Georgian Period 1750-1776 – The Town of Gill is typical of many of the towns in western Massachusetts in that it was part of sev-

eral divisions of larger allotments of land to proprietors and to townships before being established in its own right. In this case, it was part of the property of the Proprietors of Deerfield between 1682 and 1753 when it was parceled off as part of the district of Greenfield. It remained the northeast part of Greenfield between 1753 and 1793 when the Massachusetts Senate and House of Representatives approved its designation as the new district of Gill. At that time there were sixty-one men petitioning for the separation suggesting the size of the settlement. Gill was legally incorporated as a township in September of 1793 and three months later received its corporate privileges. At the time of its formation as a district, Gill Center was reached by Straits Road from Greenfield, some of which had been laid out in 1736 and extended to Gill Center about 1775. It served as a north-south roadway, while Center Road, laid out in 1775 as well, served for east to west travel. Farming was the principle occupation of the settlers, supplemented, in the case of Ithmar Allen and David Squires, by mill work, blacksmithing and potash processing, by others' cabinetmaking, wheel-making, store and tavern-keeping. A schoolhouse was built before 1775 at the junction of Center Road and Main Road.

If you have time to volunteer and help with projects, please let one of the GHC members know of your skills and interest. The Gill Historical Commission (GHC) meets on the third Tuesday of each month at 5:30 PM, unless otherwise posted, in the Riverside Municipal Building on Route 2. The GHC is charged with planning for the preservation of Gill's historical sites and records as well as educating residents about the history of their town. 
