I am writing on behalf of the Gill Elementary School to request \$2386 from the Quintus Allen Fund to be used to set up freestanding netting to go around the blacktop where the basketball hoops are. The blacktop tends not to be used as much as students and staff would like, as the basketball hoops have no netting behind them or backstops. This results in students continually chasing balls down into the woods and fields. The PE teacher, Ron Wood, is in full support of this plan as it would allow us to expand our PE programming.

This purchase would include:

- 2 "Stop that Ball" net systems (50 feet long each) @ 849.99 each
- 1 "Stop that Ball" 10 foot extender kit @ 199.99
- Cost for shipping is 367.99
- Cost for taxes is 118.74

EDUCATION AND OUTREACH PLAN

- 1. Flyers and pamphlets have been provided by the Cooperative Public Health Service District of the Franklin Regional Council of Governments, and will be available at the Town Hall and Slate Memorial Library. Flyers will be offered to high-traffic local businesses such as Upinngil Farm Stand, The Mill (gas station/convenience store), Spirit Shoppe (package store), Wagon Wheel (restaurant), and Cielito Lindo (restaurant).
- 2. Educational articles will be placed in The Gill Newsletter, the quarterly town-sponsored newsletter that is mailed to every postal customer in town. Articles will remind residents to be on the lookout for standing water and give other general educational information about mosquito mitigation.
- 3. Information will be posted on the town website, www.gillmass.org
- 4. Information will be posted on the Town's Facebook page, https://www.facebook.com/TownOfGill
- 5. The Board of Health and Conservation Commission will work with the Gill Elementary School, Four Winds School, Northfield Mount Hermon School, and local camps, providing information about mosquito management and best practices.
- 6. The Town will continue its efforts to keep culverts and catch basins clean. Residents will be asked to report standing water in roadside ditches so the Highway Department can inspect and take appropriate action.
- 7. In the event a High or Critical risk level for Gill is issued by the Massachusetts Department of Public Health, the Town can utilize its Reverse911 system to inform the public of the increased risk and precautions than can be taken.

RE: Town of Gill – 2022 Opt Out & Alternative Mosquito Management Plan Application

On May 23, 2022 at 4:30 PM, the Gill Selectboard held a duly posted public meeting to discuss whether the Town of Gill should opt out of the mosquito control spraying conducted by the State Reclamation and Mosquito Control Board and to review the Town's Alternative Mosquito Management Plan for 2022.

The Gill Board of Health held a duly posted public meeting on May 10, 2022, discussed opting out, and made a recommendation to the Selectboard that the Town should again exercise the choice to opt out of all mosquito spraying activities conducted by the State. This recommendation was considered by the Selectboard at their May 23rd meeting.

At the May 23rd meeting the Selectboard allowed public comment on opting out of the mosquito control spraying and on the Alternative Mosquito Management Plan.

At the conclusion of the discussion and deliberation, the Selectboard voted in favor of opting out of all mosquito control spraying activities conducted by the State Reclamation and Mosquito Control Board in the Town of Gill under MGL Chapter 252, Section 2A and to submit an Alternative Mosquito Management Plan application.

The approved application is enclosed. The Town acknowledges the vote to opt out will only be honored if all opt out application components are submitted to EEA on time and if the application is approved by EEA.
