SELECTBOARD MEETING MINUTES August 26, 2024

<u>Called to Order</u>: The meeting was called to order at 5:30 PM in the 2<sup>nd</sup> floor meeting room at Gill Town Hall.

<u>Members Present:</u> Randy Crochier, Charles Garbiel <u>Members Absent</u>: Greg Snedeker <u>Others Present:</u> Ray Purington, Town Administrator; Kate Savage, and Tim Batchelder

Randy Crochier chaired the meeting in the absence of Greg Snedeker.

Review of Minutes: No minutes were available for review and approval.

<u>Petition to Discontinue Mt Hermon Road as a County Road:</u> On May 17, 2024, roughly two weeks after the topic was discussed at Gill's Annual Town Meeting (May 6, 2024), the Northfield Mount Hermon School filed with the FRCOG a county road petition to discontinue Mt. Hermon Road. The Town was notified the FRCOG's Executive Committee will hold a hearing on the petition on September 12, 2024. Additionally, the Executive Committee has asked to know the Selectboard's position on the discontinuance.

Ray presented a draft of a letter to the Executive Committee based on the discussion from the Town Meeting. The draft letter states the Selectboard is in support of the discontinuance, and lists several reasons why, including that the road only serves School-owned properties, the School intends to keep the road open for campus traffic and emergency vehicles, and the cost to maintain the road exceeds the Chapter 90 aid received for the road each year. Charles made a motion, seconded by Randy, to approve the letter and authorize Ray to sign and submit the letter on behalf of the Selectboard. The motion passed by a vote of 2 in favor and 0 opposed.

<u>Appointments:</u> Charles made a motion, seconded by Randy, to appoint Noah Welch-Smith as a Firefighter through June 30, 2025. The motion passed by a vote of 2 in favor and 0 opposed. Charles made a motion, seconded by Randy, to appoint Katie Simpson to the Town Forest Committee through June 30, 2025. The motion passed by a vote of 2 in favor and 0 opposed.

Savage left the meeting at 5:35 PM.

<u>Warrant:</u> The Selectboard reviewed and signed the FY 2025 warrant # 5 with totals of \$53,681.41 for vendors and \$32,033.45 for payroll.

The meeting adjourned at 6:15 PM.

Dear Mr. and Mrs. Chudzik:

This letter is to inform you that the Gill Selectboard met on June 17, 2024 at 6:30 PM under the provisions of Massachusetts General Law, Chapter 140, Section 157 to act upon a request from Maurice Dumas for a Dangerous Dog hearing for your dog Rothgar. You were informed of the hearing via my letter dated June 10, 2024. You attended and participated in the hearing on June 17, 2024.

During the hearing Animal Control Office (ACO) Kyle Dragon summarized the circumstances of a recent documented case in which Rothgar bit your neighbor, Linda Croteau, on her arm in her backyard on May 26, 2024. Also during the hearing several residents of the Riverside neighborhood described prior incidents involving Rothgar and other pets in the neighborhood, including an attack on another dog from January 2022. Additionally, there were stated concerns about Rothgar's disposition and your inability to control or restrain Rothgar when he is on a leash. Your objections to some of these statements were noted.

During the hearing you voluntarily stated your plan is to move out of Gill, probably to a location in New Hampshire, likely by "the end of the summer." The Selectboard understands this is your decision to make, and notes leaving town was in no way suggested or recommended by the Selectboard or any official or agent of the Town.

You also stated during the hearing you hope to have Rothgar seen by a dog behaviorist in Maine who specializes in working with German Shepherds, which is Rothgar's breed. We wish you well in this endeavor and hope for a successful outcome.

The Selectboard listened to the testimony of those in attendance, asked questions and received answers. The Selectboard confirmed neither you nor ACO Dragon had any further comments or statements, and then voted unanimously to close the hearing. After their deliberations the Selectboard voted unanimously to deem the dog Rothgar to be a Dangerous Dog and ordered the following measures:

- 1. The dog shall be humanely and adequately restrained. However, the dog is not to be chained, tethered or otherwise tied to an inanimate object including, but not limited to, a tree, post or building.
- 2. The dog shall be humanely and adequately confined to your property at 32 Walnut Street, Gill. 'Confined" shall mean securely confined indoors or confined outdoors in a securely enclosed and locked pen, kennel, or dog run area located at 32 Walnut Street, Gill.
- 3. A securely enclosed pen, kennel or dog run shall be constructed on your property and used to confine the dog at all times when it is outdoors and off leash. The pen, kennel or dog run must

be constructed of adequate materials to prevent escape, and must be kept in good repair. Within the pen, kennel or dog run there must be a dog house or proper shelter provided to protect the dog from the elements.

- 4. Any time the dog leaves your property at 32 Walnut Street, Gill, it shall be securely and humanely muzzled and restrained with a chain or other tethering device having a minimum tensile strength of 300 pounds and not exceeding 3 feet in length.
- 5. As the owner of the dog you shall provide to the Board of Selectmen and ACO Dragon proof of insurance in an amount not less than \$100,000 insuring you against any claim, loss, damage or injury to persons, domestic animals or property resulting from the acts, whether intentional or unintentional, of the dog or proof that reasonable efforts were made to obtain such insurance if a policy has not been issued.
- 6. As the owner of the dog you shall provide to the Board of Selectmen and ACO Dragon information by which the dog may be identified, throughout its lifetime including, but not limited to, photographs, videos, veterinary examination, tattooing or microchip implantations or a combination of any such methods of identification. You shall also provide to the Board of Selectmen and ACO Dragon the street address of the location where the dog is living or being kept.
- 7. These orders shall remain in place until lifted or amended by a vote of the Selectboard.

Orders #1 (restrained), 2 (confined), and 4 (muzzled) went into effect immediately after the vote and must be abided by at all times. Orders # 3 (construction of pen), 5 (insurance), and 6 (identification and location) must be completed within 10 days of your receipt of this letter.

If you wish to appeal the Board's decision, you have 10 days from the date of this letter to file an appeal in the Clerk Magistrate's office of the Greenfield District Court located at 43 Hope Street in Greenfield.

I am writing in response to the recent order from the town of Gill Board of Selectmen regarding the deeming Rothgar a dangerous dog and subsequent installation of a kennel or dog run on my property at 32 Walnut St. in Gill.

I would like an amendment to this decision as I feel that my voice was not adequently heard in this matter. Due to my professional commitments as a Technical Resinous Floor Specialist for large projects, I am often required to travel extensively, sometimes for long periods of time. I am currently unable to attend a meeting until the middle of October. I am in the process of selling the property and relocating to New Hampshire. The property will be on the market in September, and we are actively pursuing listings.

I would like to bring to your attention that we have previously taken measures to address dog enclosure by investing in \$7000 worth of stockade fencing. Additionally, installing a kennel or dog run would reduce the property's value, possibly hurt our ability to sell the property.

In the interim, we will ensure that our dog, Rothgar, remains within the stockade fencing or indoors. And will keep Rothgar leashed if the need to travel outside occurs.

I kindly request your understanding and consideration of my circumstances in this matter. I appreciate your attention to this issue.
